Objectives

The aim of this course is to give an overview and a clear understanding of the political, institutional, and historical dimensions of the EU and of European integration. Part of the course investigates and discusses different theoretical perspectives, thereby enabling students to understand and interpret the recent transnational developments critically. A part of the course is devoted to the understanding and problematization of some of the most controversial contemporary issues such as the current economic crisis in the Eurozone, prospects for further political integration, and enlargement.

CORE QUESTIONS:

- What is the EU?
- What are the main institutions of the EU and how do they work?
- How are decisions and policies made in the EU?
- Where is the EU going? How sustainable it is in the long term?
- Which are the lessons that can be learned from the past mistakes in the process of European integration?
- What is Estonia's role in the EU?
- How far should/can European integration go?
- Is the EU democratic and legitimate?

Learning outcomes

At the end of the course, student will have a solid understanding of the nature, foundation, history, and overtime institutional and political developments of the EU. They will have developed a critical perspective on the major achievements of European integration and will be able to problematize the most relevant EU-related issues.

By the end of the course students are expected to:

- Be familiar with the EU development and structure
- Critically read the institutional and political developments EU and discuss the future trajectories
- Contextualize the EU within the debate on federalism, inter-governamentalism, functionalism, etc.
- Be able to discuss the most recent and most relevant pan-European issues
- Understand (and problematize) the democratic and political process in the EU
- Be familiar with the EU policy-making

Brief description

The lectures will provide a general and multifaceted overview on the political-institutional developments of the EU and its history. In particular the following aspects will be discussed: the integration process over time, the most recent institutional developments, the EU's theoretical foundation and the main related concepts, the Union's institutional, political, and economic nature, and the tension between "widening" and "deepening". Group discussion is favoured.

Students' independent work is a key and fundamental element of the course. It is fundamental for a successful and proficient learning process and - as such - it will be evaluated and assessed during every meeting. Students are expected to work independently between sessions. This is crucial both in order to better interiorize the notions and experiences acquired during the preceding session (i.e. individual reflection on the results of the class discussion and application of the introduced research methods) and to prepare the informative background necessary to successfully participate to the successive meeting (preparations for the discussions in class).

List of independent works and their instructions

The final evaluation will be based on the assessment of different learning components: written critical review (2), preparation of the simulation/negotiation exercise (1), and final test (1).

Assessment methods and criteria

final written assessment	Final written exam: The last class meeting will be devoted to a final written exam. It consists of a mix of open and closed questions addressing the main
	dimensions discussed during the course.
demonstration	In the last meeting students will be involved in a negotiating exercise of the Council of the EU where the knowledge and notions acquired during the lectures and the seminars are tested and put into practice. In particular, students are grouped as representatives of Member States. Students' activism is taken into account and the preparation of the material assessed on a differentiated basis.
home work	Written assignments: Throughout the course, students are expected to submit two short critical assessments based on the proposed articles (around 600 words). A collective discussion will follow during the successive class meeting.

Requirements to be met for final assessment

In order to be considered for the final assessment, students are expected to attend at least 4/5 of the classes and actively participate to class activities, submit at least 1 of the 2 written critical review, and prepare the material for the simulation/negotiation exercise.

The components of the final evaluation will weight in the definition of the final grade according to the following percentages and distribution of points:

Preparation of simulation/negotiation exercise (30% of the final grade): 30
